



How did we do it?

Early Awareness Campaign:	Initiated proactive measures by addressing the issue early, starting with a presentation at the November Board of Education (BOE) meeting to highlight the significance of State Assessment participation.
Continuous Communication:	Maintained consistent communication through platforms like the Ken-Ton Connection, emphasizing the importance of student participation in State Assessments and keeping families informed about the process and its implications for educational outcomes.
Revised Procedures:	Implemented a revised procedure on how families are to inform the district if they refuse to allow their children to participate in state tests, ensuring clear communication and accountability while respecting parental choices.
School Leadership Engagement:	Enlisted the active involvement of school leadership in reinforcing the importance of State Assessments, fostering a culture that prioritizes student participation and encourages collective efforts towards academic excellence.
